

Terms of Use

1. Agreement to Terms

These Terms of Use ("Terms") govern your access to and use of the website located at spacehousegames.com (the "Site") operated by Space House Creations LLC, doing business as Space House Games ("we," "us," or "our"). By accessing or using the Site, or by placing an order, you agree to be bound by these Terms. If you do not agree, please do not use the Site.

2. Eligibility

You must be at least 18 years old to make a purchase through the Site. By using the Site, you represent that you meet this requirement and that the information you provide is accurate and complete.

3. Products

We sell physical goods through the Site. We make reasonable efforts to display our products, including colors and descriptions, as accurately as possible. However, we do not warrant that product descriptions, pricing, or other content is accurate, complete, current, or error-free. Colors may vary depending on your device's display.

We reserve the right to limit quantities, discontinue any product, or correct errors, inaccuracies, or omissions at any time without prior notice, including after an order has been submitted.

4. Orders, Pricing, and Payment

All prices are listed in U.S. dollars and are subject to change without notice. Placing an order constitutes an offer to purchase, which we may accept or decline.

We reserve the right to refuse or cancel any order for any reason, including suspected fraud, pricing errors, or product unavailability. If we cancel an order after your payment has been processed, we will issue a refund to your original payment method.

You agree to provide current, complete, and accurate purchase and account information for all purchases. You authorize us (or our third-party payment processor) to charge your payment method for the total amount of your order, including applicable taxes and shipping charges.

5. Shipping

We currently ship only within the United States. A flat-rate shipping charge applies to each item and is shown at checkout. Shipping times can take up to 5-7 business days. We are not responsible for delays caused by carriers, weather, or other circumstances beyond our control. Risk of loss and title for items pass to you upon delivery to the carrier.

6. All Sales Final; Defective Items

All sales are final. We do not accept returns or exchanges for reasons of buyer's remorse, change of mind, or similar. If an item arrives defective or damaged, you may return it to us at no cost to you within 30 days of delivery. To initiate a claim, contact us at contact@spacehousegames.com with your order

number and a description or photos of the defect. Upon approval, we will provide a prepaid return label and, following our receipt and inspection of the item, issue a replacement or a refund to your original payment method.
